INFORMAL CARERS FINALLY RECOGNISED

The Dept. of Communities Tasmania has undertaken a review of informal kinship care arrangements completed in November 2020. The government accepted all eight recommendations. Kin Raising Kids is incredibly grateful to the Minister, Roger Jaensch for his efforts in bringing about this groundbreaking recognition. This will include the development of a service to deliver practical assistance, advocacy support, help to navigate programmes and to ensure access to assistance to which informal kinship carers may be eligible.

Informal Kinship Carers being recognised!

The eight (8) recommendations are:

1. Establish and pilot an Informal Kinship Care Support and Liaison Service
2. Expand the eligibility of the Grandchildren Living with Grandparents Program
3. Expand the availability of training and awareness raising programs
4. Improve the availability of information and resource material for informal kinship carers
5. Review relevant Child Safety Service Client Files
6. (a) Explore government policy options and definitions that might be available to improve access to informal kinship carers, who are the responsible adults and have primary care responsibilities to meet the needs of children in their care, to improve support in:
(b) Consider options for extending criteria to existing Government programs to improve the Government's support to informal kinship carers, including:
7. Consider changes to the Children, Young Persons and Their Families Act 1997
8. Continue national advocacy

On 16th March 2021 in his State of the State address to Parliament, Premier Peter Gutwein recognising informal carers, it was claimed Covid support was given to informal carers, when in fact they received nothing in the way of stimulus benefits.



During the recent election campaign, a KKR delegation met up with the Shadow Minister, Sarah Lovell, the Greens Leader, Cassy O'Connor and the Independent for Clarke, Sue Hickey, to seek unified support particularly for Informal Kinship Carers as this whole review proposal progresses through parliament.

Hopefully the above will more than make up for this oversight.
